# **Informational/Discussion/Presentation Items**

1. Mr. Greydanus shared the details provided by PFM financial advisors about the energy bond. The resolution to be considered on May 15 will be for up to \$700,000 for a term of up to seven years for HVAC controls and the replacement of sections of the elementary roof.

- 2. The Board discussed two options for the Community Recreation Millage. Option 1 includes the renewal of 0.4885 mill with an increase of 0.0115 mill to restore the Headlee reduction. Option 2 includes the renewal of 0.4885 mill with an increase of 0.5 mill. Both options considered are for a period of ten years, 2024 to 2033. The Board preferred Option 2. Mr. Greydanus will have the resolution drafted and placed as an action item on the May 15, 2023 agenda.
- **3.** The Board reviewed the recent Neola policy update recommendations. These will appear on the May 15 agenda for a first reading.
- **4.** The Board reviewed the proposed administrative salaries for 2023-2024.
- **5.** Mr. Greydanus will prepare a list of facility projects that should be included in the next bond proposal.
