# Informational/Discussion/Presentation Items

- 1. Mr. Greydanus shared the concept of hiring bus drivers through a third-party contractor to reduce the amount paid to the retirement system and increase the hourly take-home pay. The members of the Board did not encourage further pursuit of this option. They would rather consider asking more parents to transport their own children to and from school or consider staggered start times for elementary and secondary to reduce the number of routes needed.
- 2. Mr. Greydanus shared the approach the District has taken to handling sensitive issues regarding gender and sexuality. Our staff members are expected to respect the student's gender expression without pushing their own agenda.

- 3. Mrs. Gierucki presented an update on the MTSS work that has been gaining traction in each of the buildings. Teachers are taking more ownership of PLCs and suggesting ways to make this designated time productive and beneficial.
